Tools for Justice: Increasing Legal Assistance for Human Trafficking Survivors

Through the 4Bells app, anti-trafficking service providers and advocates will post their clients' legal needs, which will then match only to lawyers with the relevant expertise from the pool of legal participants. If you are a match, you will be immediately notified and be able to review and respond to the request for assistance in the app. With direct and easy access to legal resources and knowledge, precious time is not wasted on coordination, and more of the survivors' diverse, pressing problems can be expediently resolved.

## **Role in the Pilot**

- Review real-time notifications of requests for assistance that match your expertise
- Claim requests where you are willing and able to assist, and the 4Bells app will directly share your contact information with the service provider or advocate who posted
- Discuss further terms of the task when service provider or advocate calls you

Communicating with the service provider or advocate directly ensures you have an opportunity to protect client confidentiality, explain the scope of assistance and retain existing institutional expertise around client intake and project management.
