In 2021, the Freedom Collaborative, a platform for global anti-trafficking efforts, recognized ALIGHT's model as unique in the world. ALIGHT has been invited to present this innovative work at the 2017 United Nations Conference on the Status of Women's human trafficking event, the Princeton Center for Information Technology Policy and the Freedom Network.

# **Position Description**

This position is an opportunity for a social worker or social work candidate who is passionate about ending human trafficking to work closely with the legal community to fight for survivors' rights. The Intake Advocate provides critical support for our warm line for human trafficking survivors. In this role, the Intake Advocate works remotely to screen (by phone) for human trafficking and other eligibility requirements, triage with referrals to community resources for non-legal needs, identify legal issues and post survivors' requests for legal help through our app. Once attorneys respond to requests on the apps, the Intake Advocate helps the survivor connect to the attorney for the pro bono advocacy, counsel and/or representation requested, as well as conduct follow-up where needed. This role is central to serving the most vulnerable and bridging the gap to meet their legal needs.

The Intake Advocate will receive ongoing training in trauma-informed practices, standard procedures, data entry and specialised legal education in order to provide the highest level of legal information and community resource referrals under the supervision of the Executive Director. The Intake Advocate will have the opportunity to consult with an experienced Intake Advisor and Survivor Leader where needed.

The Intake Advocate joins the program team on a part-time basis of 8 up to a maximum of 25 hours per week at \$22 per hour. Responsibilities include working remotely to conduct outreach, on-boarding and follow-up with attorneys. This position works closely with the Executive Director, Legal Associate, Program Associate and Intake Advisor. Strong work ethic, proactive attitude and comfort with working remotely required. LCSW, MSW or MSW candidate preferred. Fluency in Spanish a plus. This is a independent contractor position that depends on grant funding beyond 2022.

#### Qualifications

- Has completed a BSW, LCSW, MSW or MSW candidate preferred.
- Holds at least 1+ year in prior intake experience and/or prior experience working in legal aid, the court system, a law office or agency that serves vulnerable populations.
- Fluency in Spanish a plus.
- Received trauma-informed training.
- Passionately advocates for justice and survivor-centric solutions for vulnerable groups and individuals
- Willing to provide a background check before starting employment (we welcome pre-disclosure and discussion regarding any sensitive information)
- Strong verbal and written communication skills, including strong data entry and typing skills.
- Availability for weekly or biweekly team meetings via video conference.
- Ability to learn and retain new information quickly.
- Strong organizational and time management skills.
- Ability to be flexible and adapt to various client situations and changes in program procedures.
- Ability to manage stress and identify self-care as needed.
- High level of attention to detail and accuracy.
- Ability to analyze and problem solve quickly.
- Strong interpersonal skills Has proven ability to work well independently, innovate, problem-solve, collaborate and meet deadlines.
- Holds sincere commitment to work collaboratively with all constituent groups, including staff, board members, advisory council, volunteers, donors, program participants and other supporters.
- Comfort in an entrepreneurial environment and proficiency with mobile technology, remote working tools and Google applications. Has secure internet connection.
- Proven and demonstrable track record of success working in related industry/sector.
