Founded as a 501(c)(3) nonprofit organization in Colorado in 2015, ALIGHT connects survivors' diverse legal needs to untapped expertise in the legal community in Colorado, Utah, Los Angeles and beyond. ALIGHT works with social service providers and community organizations that support different vulnerable populations in order to help the human trafficking survivors they serve connect to the right attorney, at the right time.

ALIGHT's leadership in pioneering and implementing an innovative model for legal services delivery for survivors (think: Lyft app for specialized pro bono services) has been nationally and internationally recognized. In 2020, the American Bar Association passed Resolution 113 that promoted the need for the innovative tech-based model that ALIGHT established in Colorado. In 2021, the Freedom Collaborative, a platform for global anti-trafficking efforts, recognized ALIGHT's model as unique in the world. ALIGHT has been invited to present this innovative work at the 2017 United Nations Conference on the Status of Women's human trafficking event, the Princeton Center for Information Technology Policy and the Freedom Network.

#### **Position Description**

This position is an opportunity for an attorney or law student who is passionate about ending human trafficking to work closely with the legal community to fight for survivors' rights. The Legal Associate focuses on placing human trafficking survivors' legal cases with attorneys and on growing and supporting ALIGHT's mobilized network of attorneys. This role is central to serving the most vulnerable and bridging the gap to meet their legal needs.

The Legal Associate joins the program team on a part-time basis of 10 to 20 hours per week at \$25 per hour. Responsibilities include working remotely to conduct outreach, on-boarding and follow-up with attorneys. This position works closely with the Executive Director and Intake Advocate. Strong work ethic, proactive attitude and comfort with working remotely required. JD or JD candidate preferred. This is a temporary, contract-based position to cover January through May 2024, commencing no later than January 9, 2024. Opportunity for growth and continued involvement beyond that period.

## Responsibilities

# Recruit, screen and train attorneys to join the program:

- Research and identify potential attorney partners to participate in the program.
- Initiate, build and strengthen relationships with potential attorney partners.
- Conduct remote onboarding of attorney and community service partners, including reference checks.
- Train attorney and community service partners on the use of technology, collaborative practices and trauma-informed considerations for working with survivors.
- Assist with the development of vicarious trauma resources for attorneys working with survivors.

## Support field use of program technology and support community-building:

- Assist attorney and community service partners with technology setup (i.e. downloading and working the app).
- Research and provide additional resources, as necessary.

 Regularly interact with attorneys and community service providers to build relationships, represent ALIGHT at community events and support initiatives to bolster participant engagement in the program.

## Collect and analyze program data:

- Conduct follow-up on ongoing cases, including surveys and other communications.
- Utilize Asana to track progress and provide status updates at weekly virtual team meetings.
- Record and analyze results in ALIGHT systems within Google Docs.

#### Qualifications

- Has completed, or is in the process of completing, a graduate degree in a field relevant to ALIGHT's work (J.D. or knowledge of legal system preferred).
- Holds 1+ years of experience in positions requiring legal content knowledge and experience.
- Passionately advocates for justice and survivor-centric solutions for vulnerable groups and individuals.
- Communicates clearly and effectively and is adept at networking and relationship-building.
- Has strong organizational skills and a self-starter mindset to develop relationships (sales and/or recruiting experience a plus).
- Has proven ability to work well independently, innovate, problem-solve, collaborate and meet deadlines.
- Holds sincere commitment to work collaboratively with all constituent groups, including staff, board members, advisory council, volunteers, donors, program participants and other supporters.
- Comfort in an entrepreneurial environment and proficiency with mobile technology, remote working tools and Google applications. Skilled at Excel analytics and reporting functionality.
- Proven and demonstrable track record of success working in related industry/sector.
- Operations, processes and tech systems experience a plus.
